The meeting was called to order at 7:31 by Paul. The Pledge of Alliance and a prayer followed.

#### Minutes

Jean moved and Tim seconded a motion to approve the minutes of the February 19 Public Hearing and Meeting as presented. The motion was approved.

#### Remount of 371 (2017 ambulance)

The remount of Unit 371 was tabled from last month's agenda. Derek reported the vendor said he could submit a new quote for FY2027. No action was taken.

#### **Old Business**

#### **County Commission**

Derek reported the FY2026 budget was presented to the County Commission with a projected monthly draw of \$70,000 from the fee account. He was asked to resubmit the budget with a \$60,000 and \$65,000 draw. Derek presented a revised budget with those parameters, cutting personnel to attain a balanced budget. He predicts the draw will remain at \$65,000 for FY2026. The commission will vote on Tuesday, March 18.

Steve said the commission has discussed increasing the Emergency Ambulance Fee, but nothing has been decided.

#### **Update from West Hardy EMS (Company 21)**

Dave Pratt reported 100 calls for service, of those, 62 were transports, 31 were refusals (12 signed), 3 no transport, 1 cancelled on scene, 1 cancelled prior to arrival, 1 no patient contact, 1 transported by another EMS crew.

Dave also reported, the new remounted ambulance is scheduled for deliver in August.

Dave reported the past few days have been very busy.

#### **Update from HCEAA and Wardensville**

Nathan reported 73 calls for service, of those 41 were transports, 30 were non transports, 2 were dropped with Co. 21 responding.

#### **Invoices**

Derek submitted an invoice list for February. Roger moved and Tim seconded a motion to pay February invoices.

#### **Comments from Board and Public**

Roger reported he visited Wardensville, got a feel for their operation and commended their volunteer spirit. He also visited with West Hardy to go over budget issues. He met with Nathan and Derek during the budget process.

Fran asked if he found anything out of the ordinary. Roger said there was nothing earth-shattering. His purpose was to "cut the fat" from the budget, then "cut to the bone."

Fran asked about staff availability. Roger said we are asking Wardensville to cover another shift. Lisa Twig said they are being asked to cover 3 - 4 shifts and it is not possible, when everyone who volunteers also works full time.

Paul said the County Commission has to provide service to the level it can afford.

Lindsay said the expenses have increased but the money coming in hasn't increased.

Billie Jo said decisions are being made that effect the entire county. If HCEAA cuts crews, they are asking others to take up the slack.

Michaela said if Wardensville picks up a call in Mathias and has to go to Rockingham, it takes 4 - 5 hours.

Roger said both Derek and Nathan will pick up another shift. He also said in three days, there was less than one call (on average) per day.

Fran said you can't lookout this as a commercial business, people's lives are at stake.

Roger said it is clear everyone is dedicated to providing the best service possible.

Lindsay said it's like we're going backwards.

Derek said we average 3.5 calls per day on the east side. There is an increased reliance on volunteer hours.

Billie Jo asked when are Derek and Nathan going to work full time? They are picking up a shift, but HCEAA is cutting three shifts.

Terena asked how many days are Derek and Nathan at the station?

Becky asked why West Hardy isn't audited? She said Wardensville is audited every year by a private accounting firm (R.Thomas & Assoc.)

Steve said he thinks they should be audited, but the MOU says HCEAA Board can inspect their books at any time.

Billie Jo said she would welcome anyone who wants to come and look at West Hardy books. Dave reported St.Joseph in Parkersburg is closing. West Virginia is losing another ambulance service.

Jean reported the Salary Enhancement funds from the state are being cancelled. Last year, the state allocated \$25 million for fire and EMS. Now the state says there is no money.

Fran moved and Tim seconded a motion to adjourn at 7:31.

The next meeting of the Hardy County Emergency Ambulance Authority will be held on Monday, April 21 at the Baker Buildings, 17940 SR 55 in Baker. The meeting will begin at 6:30 p.m.
