President Paul Lewis called meeting to order at 6:32pm, followed by Pledge of Allegiance and Prayer.

#### **December Minutes:**

Motion made to approve December minutes by Fran, 2<sup>nd</sup> by Tim Thorne, motion carries

#### **Treasurer Report:**

Derek reports as of January  $1^{st}$ , total expenses for the month of December \$76,472.60. The total revenue for the month of December was \$90,865.27. Currently the checking account has \$12,054.72 and the savings account has \$133,419.60.

#### **Ambulance Calls:**

Paul reports the 911 center is fully staffed, has 1 extra to use for fill in.

New equipment, Stryker Cot and Monitors, that were approved on the bids from the special meeting on 12/29 have been ordered. 6–12 week delivery date.

#### Vehicles:

Update from Fran regarding purchase of open trailer – she has not been able to catch up with Eugene Rinker to update any changes.

#### **New Business:**

#### **Commission Meeting:**

Representative from Alex Mooney's office attended the meeting and mentioned a project they are working on with Randolph County EMS and obtaining lift systems.

Lift systems are rated for up to 850 lbs, the lift assist in lifting the cot into the ambulance so providers do not have to strain their backs in lifting a patient into the ambulance.pr

EMS providers have not discussed obtaining the lifts due to the costly price tag that comes with purchasing.

Derek is working with Wendy in the Commission office to find out more information, but ideally it would be beneficial to have them on all units, realistically one unit for each of the companies in the county.

#### Approval to pay invoices:

Motion made for approval to pay invoices by Tim T, Ron 2<sup>nd</sup>. Motion carries

### **Board Member and Employee Comments:**

Fran posed the question to Co. 1 if they had identifying uniforms or identification badges? Fran asked the question because of an ambulance call that occurred previously at the Kac Ka Pon restaurant. Tom stated that Co. 1 does have shirts but do not wear them. Most of the time staff is not at the station at the time of a call and do not have time to go home to change or to grab a badge.

Dave from WHEMS stated the state of WV does not require badges or uniforms. All that is required is certification. He keeps his certification on a thumb drive. Others stated if they leave badges in their vehicle they may not be driving that vehicle that day so they would not have the badge.

Doug extremely upset that what he commented in the previous meeting was taken out of context and reported by newspaper incorrectly. His comments were from an observation of video and comments from people in the restaurant. He is extremely upset that it went to social media. His business has been attacked and wants his business be left out of the entire thing. He also stated the real news was in

regards to the mask mandate for EMS providers and why there were EMS Staff not wearing mask which none of that was not mentioned anywhere in the article.

Discussion among everyone regarding the statistics about the mask and Covid-19.

Dr. Rexrode commented that in regards to statistics, the state is sampling for certain variants.

In the first ten days of 2022, there have been 50 run sheets and 15 of them are non-billable refusals. It was suggested, if we could educate the public that ambulance services are there to transport patients to the hospital, not to treat you.

Milda with the Moorefield examiner stated that she had no intent to villainize Doug in her article. Mary Jo Johnson with WHEMS said she was at that meeting and the article was not incorrect.

Fran apologizes for bringing up the subject.
