Old Business:

Building/ Equipment/Vehicle/Supplies Update- The Baker building did have some plumbing problems that has been repaired. There is a problem with the trash in the building. We need to find a solution to the problem.

Fraley's, Wardensville, Mathias/Baker, & 911 Center Updates- Fraley's has been very busy lately. They have new people coming in. Wardensville – Things have been quiet over the holidays, they have had about 4 calls. Mathias/Baker- They have been really good with having a driver, but not so good on having EMT's, 98% of their calls are made with the help of the HCEAA paramedics. They are lacking EMT's.

Per-call Payments- For December 2014: Fraley's- 96, Mathias/Baker- 48, and Wardensville had 25. HCEAA medics ran 55 calls.

Shirts, Coats, Protective Clothing- We had decided at the last meeting we were going to order the jackets with Fraley's. The "HCEAA" lettering will be on the front and the letting "PARAMEDIC" on the back on the jacket.

Part & Full Time Employment- Bradley Gray has been spending time with some of the medics and drivers. Leo Casto is still interested in working the HCEAA as a paramedic.

Grant Application- If we want to apply for this grant we need to act soon. We are in need of new chase units. We need to look at the state bid and see what is available.

Training/EMT Class- It is \$15.00 to pre-register for Fraley's, the class will start 1/21/2015. Class cost is \$225.00 and you'll need to buy the books that are around \$100.00. Mary is trying to have an ITLS (International Trauma Life Support) class. February 7th, 2015 there is an ACL class. (Advantage Cardiac Life Support)

Prosecuting attorney Report- Lucas See's response on the Mr. Ovid Need situation is that the HCEAA has the right to sue but he recommends not to proceed at this time. The board took no action on this matter.

Yvonne See Retirement- President Greenwalt thanked Mrs. See for her commitment and dedication to the county and suggested the HCEAA write a thank you letter to her. The board agreed.

New Business:

County Commission/Court Report- The county commission did approve \$50,000 for continued operations of the HCEAA.
